TRANSAMERICA PREMIER LIFE INSURANCE COMPANY

AGENCY CONTRACT

(FOR USE WHEN A PERSON OR ENTITY HAS AN EXISTING AGENCY CONTRACT WITH TRANSAMERICA LIFE INSURANCE COMPANY FOR SUBMITTING BUSINESS THROUGH TRANSAMERICA BROKERAGE)

This is an agreement effective on the date of contract set forth below between **Transamerica Premier Life Insurance Company** and the agency named below. This agreement pertains to those submitting business though the distribution unit known as Transamerica Brokerage (previously known as Transamerica Insurance and Investment Group or "TIIG").

RECITALS:

- **A.** The agency and Transamerica Life Insurance Company ("TLIC") are parties to an agency agreement which pertains to the solicitation of applications for life insurance products through the distribution unit known as Transamerica Brokerage (the "TLIC Contract").
- **B.** The agency and Transamerica Premier Life Insurance Company want to enter into a contract between themselves which has the same terms, conditions, and provisions as in the TLIC Contract.

AGREEMENT:

Now therefore, in consideration of the above recitals and the covenants, conditions, and provisions set forth below, the parties hereby agree as follows:

- The parties hereby enter into a contract with the same terms, conditions, and provisions as those contained in the TLIC Contract except (1) all references to Transamerica Life Insurance Company (or "we," "us," or "the Company") shall instead mean and refer to Transamerica Premier Life Insurance Company and (2) the date of contract shall be as set forth herein below.
- 2. The contract set forth herein is entirely separate from the contract set forth in the TLIC Contract. The rights and obligations of TLIC and Transamerica Premier Life Insurance Company are entirely separate and neither insurance company shall have any right or obligation with respect to the rights or obligations of the other insurance company.
- 3. This instrument may be signed by facsimile or reproduced signature and any such facsimile or reproduced signature will have the same force and effect as an original.
